At this time President Johnson turned the meeting over to Dr. Kelly who in turn turned it over to Mrs. Freifelder for her 2nd budget presentation –

PRESENTATION: The governor has not sent out information on the budget yet, and it looks like a 2.5% increase in state aid but that is a guesstimate. This year the tax cap is 1.62%. Spending can be increased by about \$900,000. It looks like the tax levy will not go up that much this year – just a guesstimate. If districts come in under the tax cap, the taxpayers will receive a rebate check from the state equal to the difference in their taxes from last year to this year. This coming year in addition to being under the tax cap freeze, in order to get that rebate check, the governor said districts have to show savings on the tax levy of 1% in every year of five years in the future. Reducing the amount of staff will not count toward meeting the 1% requirement unless enrollment drops. School districts are getting together to look at ways to save such as joint purchasing on school supplies, collaborating on transportation, collaborating on special education services totaling an additional \$550,000. This is the first time we have not received a governor's run. We will report more information to the community as soon as we hear from the governor. School districts on Long Island have been seeing a decline in state aid. Amityville has realized a loss of \$14.5 million in state aid over the life of GAP. This year, \$620 per student in state aid will be lost. Next week, the capital component of the budget will be discussed. (See attachment for details on the budget presentation.)
